#### **APPLICATION REQUIREMENTS**

- Be admitted to Lane Community College as a college credit student with an assigned L number.
- Complete the required Admissions Tests in Reading, Writing and Math. To schedule an appointment for testing contact the Testing Office by going to the Placement Testing quick link through the main Lane Home Page, [www.lanecc.edu](http://www.lanecc.edu).
- Complete and submit the Early Childhood Education Application on-line, available on the Early Childhood webpage at [www.lanecc.edu/cfe/ece](http://www.lanecc.edu/cfe/ece).
- Bring completed test score sheet to the Child & Family Education office in bldg. 24/114.
- Fill out the on-line Application for Enrollment in the Central Background Registry. The form can be completed and submitted on-line at [www.childcareinoregon.org](http://www.childcareinoregon.org). There is a cost of \$3.00 for this payable at the time of submission. Confirmation of enrollment in the Registry must be submitted to American DataBank via e-mail or FAX.
- Obtain a Food Handlers Card by taking the test on-line at [www.lanecounty.org](http://www.lanecounty.org) or take the test in person at the Environmental Health Office at 125 E. 8<sup>th</sup> Avenue, Eugene. The testing fee is \$10.00. Verification of a current Food Handlers Card must be submitted to American DataBank via e-mail or FAX.
- **Current TB Test and Measles Immunization.** Students must have a TB test with documented results within twelve months prior to starting the program. You must supply proof of measles immunization or have up-to-date documented vaccination records. Information for both must be submitted to American DataBank via e-mail or FAX.
