Financial Aid Eligible Programs

To qualify for financial aid, you must be enrolled or accepted for enrollment in an eligible degree or certificate program. Not all programs offered at Lane are eligible for financial aid funding.

Eligible Programs

- Associate of Arts: Oregon Transfer (AAOT)
- Associate of Science: Oregon Transfer (ASOT)
- Associate of Science (AS)
- Associate of General Studies (AGS)
- Direct Transfer (*at least a two year program accepted for full credit toward a Bachelor's degree*)
- Most Associate of Applied Science programs (AAS) (*see Ineligible Programs below for exceptions*)
- Most One-Year Certificate programs (*see Ineligible Programs below for exceptions*)
- Most Two-Year Certificate programs (*see Ineligible Programs below for exceptions*)

Programs Requiring "Acceptance" to Qualify as a FA Eligible Program

If you are completing prerequisites for a program that has a competitive/point based admissions process, you have limited or no financial aid eligibility. Because of this, we suggest you pursue the Associate of General Studies, Associate of Arts: Oregon Transfer or the Associate of Science while completing your prerequisites. The prerequisites often fulfill the program requirements for one of these financial aid eligible degree programs.

Ineligible Programs

If you are enrolled in an ineligible program, you cannot receive federal or state financial aid, including loans. You may qualify for Private Alternative Educational loans depending on the lender you choose.

- Any collaboration program, where the degree or certificate is not awarded by Lane (*e.g. Speech-Language Pathology Assistant and Paralegal Studies*).
- Courses taken to transfer to a certificate or associate program at another school
- Prerequisite or required courses for a graduate program (*i.e., master's, doctoral, or other advanced degree*)
- A set of courses for which a Department or Division offers a recognition award or certificate (*e.g. Medical Transcription, Medical Coding, EMT-Basic, EMT-Intermediate, etc.*)
- All Suggested Courses of Study (unless all courses will be accepted for full credit at the school you choose to attend)
- AAS: Construction Trades, General Apprenticeship
- AAS: Electrician Apprenticeship Technologies
- AAS: Industrial Mechanics and Maintenance Technology Apprenticeship
- One-Year Certificate: Construction Trades, General Apprenticeship
- One-Year Certificate: Electrician Apprenticeship Technologies
- One-Year Certificate: Limited Electrician Apprenticeship Technologies
- One-Year Certificate: Industrial Mechanics and Maintenance Technology Apprenticeship
- One-Year Certificate: Occupational Skills
- One-Year Certificate: Practical Nursing (currently under review)
- Two-Year Certificate: Electrician Apprenticeship Technologies

** The coursework needed to complete a Career Pathways certificate is typically the same coursework required to earn the corresponding Associate of Applied Science degree. If it is your intention to complete the Associate degree, then you are enrolled in an eligible program. The program you list with the College should be the appropriate AAS program.
