## Getting Started

Prior to orthodontia treatment, a patient will participate in a pre-treatment consultation with a Willamette Dental orthodontist. This consultation includes an initial exam, as well as X-rays, study models and an extensive oral evaluation. The cost for this service is \$150. This non-refundable consultation fee will be credited toward the total Willamette Dental fee when the patient proceeds with orthodontia treatment.

These Willamette Dental value-added orthodontia rates are only available when a Willamette Dental general dentist or orthodontist performs the entire treatment.

Preferred employee orthodontia treatment is not an insurance covered benefit. The patient will be responsible for all fees.

## **Pre-Orthodontia Consultation Fees**

Study Models & X-rays: \$125

Case Presentation: \$0

Banding level will be determined by the orthodontist and is based on the extent of treatment.

Fees may increase from those listed; however, anyone who has begun treatment will not be subjected to any fee increases after treatment has begun or has been accepted, as long as treatment begins within 120 days from the date of consultation.
