Amount

Small quantity

Effect

User owns lawfully acquired or purchased copy of original work One or few copies made Lack of licensing mechanism

Could replace sale of copyrighted work

Impairs market or potential market for copyrighted work or derivative Reasonably available licensing mechanism for use of the copyrighted work Affordable permission available for using work

Numerous copies made

Making it accessible on Web or in other public forum

Repeated or long term use

Similar product marketed by the copyright holder

Single Copying for Teachers

A chapter in a book

An article from a periodical or newspaper

A short story, short essay or short poem, whether or not from a collective work

A chart, graph, diagram drawing, cartoon or picture from a book, periodical, or newspaper

Multiple Copies for Classroom Use

The copying meets the tests of brevity and spontaneity and meets the cumulative effect test and each copy includes a notice of copyright To create, replace or substitute for anthologies, compilations or collective works

Copying of or from works intended to be "consumable," such as workbooks, exercises, standardized tests and test booklets and answer sheets

Used as a substitute for purchase of books, publishers' reprints or periodicals

Directed by a higher authority Same item repeated by the same teacher from term to

term Charging students beyond the actual cost of photocopying

More than one copy per pupil per course

Brevity

Poetry:

A complete poem if less than 250 words and if printed on not more than two pages

From a longer poem, an excerpt of not more than 250 words (may be extended to finish a line)

Prose:

A complete article, story or essay of less than 2500 words

An excerpt of not more than 1000 words or 10% of the work, whichever is less, but a minimum of 500 words (may be extended to finish a paragraph)

Illustration:

One chart, graph, diagram, drawing, cartoon or picture per book or per periodical issue

Special Works:

An excerpt of not more than two pages and not more than 10% of the words, when combining language with illustrations, in which the entire work is less than 2500 words

Spontaneity

Copying is at the instance and inspiration of the individual teacher (not the supervisor)

The inspiration and decision to use the work and moment of its use are too close in time for a reply to a request for permission

Cumulative Effect

Copying is for only one course in the school in which the copies are made Not more than one short poem, article, story, essay or two excerpts from the same author

Not more than three from the same collective work or periodical volume during one class term

Not more than nine instances of such multiple copying for one course during one class term

Multimedia

May be Used Only for Educational Purposes in Systematic Learning Activities

Preparation of Educational Multimedia Projects Using Portions of Copyrighted Works

Students: Incorporate portions of lawfully acquired copyrighted works when producing their own educational multimedia projects for a specific course

Educators: Incorporate portions of lawfully acquired copyrighted works when producing their own educational multimedia projects for their own teaching tools in support of curriculum-based instructional activities at educational institutions

Uses of Educational Multimedia Projects

Students: Perform and display own multimedia projects for educational uses in the course for which they were created Use in own portfolios as examples for later personal uses (job and graduate school interviews)

Students: Make copies of the instructor's copy

Educators: Perform and display own multimedia projects: (a) face-to-face instruction, (b) assigned for directed self-study, and (c) for remote instruction with limited access

Use for 15 days; 1 or 2 copies may be placed on reserve for students enrolled in course

Perform and display own multimedia projects in presentations to peers (workshops and conferences)

Retain multimedia projects in personal portfolios for later personal use (tenure or job interviews) Limitations of Educational Multimedia Projects for Educators

Time: Use for 2 years after the first instructional use

Portions:

Motion Media--up to 10% or 3 minutes, whichever is less Text Material--up to 10% or 1000 words, whichever is less Poem--an entire poem of less tha

Poem--an entire poem of less than 250 words

Music, Lyrics, and Music Videoup to 10%

Illustrations and Photographs--Use in its entirety

Numerical Data Sets--up to 10% or 2500 fields or cell entries, whichever is less

Copying and Distribution--2 use copies, with 1 of them on reserve; 1 copy for preservation for possible replacement

Time: Use beyond 2 years, even for educational purposes, without permission

Portions:

Text Material-

More than 3 poems by 1 poet or 5 poems by different poets from an anthology

More than 3 excerpts by a poet or more than 5 excerpts by different poets from an anthology

Music, Lyrics, and Music Video-More than 30 seconds; any alterations that change the basic melody or fundamental character

Illustrations and Photographs--More than 5 images by 1 artist or photographer; more than 10% or 15 images, whichever is less, from a collective work

Distance Learning

Permissible

Eligibility

Nonprofit educational institutions at all levels of instruction whose primary focus is supporting research and instructional activities of educators and students but only to their nonprofit activities.

Eligible Students

Only students officially enrolled for the course at an eligible institution may view the transmission that contains works covered by these guidelines.

Works Performed for Instruction

Must be integrated into the course

Must be part of systematic instruction

Must be directly related and of material assistance to the teaching content of the transmission

For entertainment purposes

Transmission and Reception

Transmission (Delivery)

Must be over a secure system: technological limitations to the class (PIN, password, smartcard, etc.)

Reception

Must be in a classroom or place that is controlled by the institution

Copying of the portion of the class session that contains performance of the copyrighted work

Limitations

One Time Use

Performance of an entire copyrighted work or a large portion thereof may be transmitted only once

Subsequent performances, displays, or access without permission



Limitations, continued

Reproduction and Access to Copies

Receiving Institution

May record or copy classes that include performance May retain copy for up to 15 consecutive class days Students enrolled in class may view in a controlled setting

Transmitting Institution

May reproduce and provide access to copies of the transmission containing the performance of a copyrighted work

Commercially Produced Multimedia

The terms of the license apply. If there is no license, permission is required.

Commercial Uses

Any commercial use, including an educational institution conducting courses for a forprofit corporation for a fee, such as training for the employees, without permission

Dissemination of Recorded Courses

Offering instruction via distance learning and wanting to further disseminate the recordings containing a copyrighted work without permission

Uncontrolled Access to Classes

Offering the course or program to non-employees without permission

Use Beyond the 15-Day Limitation

Retaining the recorded class session beyond the limit of 15 days without permission

Music

Emergency copying to replace purchased copies which are not available for an imminent performance; purchased replacement copies shall be substituted in due course

Single or multiple copies of excerpts of works for academic purposes other than performance

Editing or simplifying

A single copy of recordings of performances by students made for evaluation or rehearsal purposes; may be retained by the institution or teacher

A single copy of a sound recording (tape, disc, cassette) owned by the educational institution or a teacher for the purpose of constructing aural exercises or examinations; may be retained by the educational institution or teacher (This pertains to the music copyright and not to the sound recording copyright.) An entire section, movement or aria

More than 10% of the whole work More than one copy per pupil To create, replace, or substitute for anthologies, compilations or collective works

Works intended to be "consumable" (workbooks, exercises and standardized tests and answer sheets)

For the purpose of performance, except in emergency

For the purpose of substituting for the purchase of music

Not including the copyright notice Editing or simplifying which distorts the fundamental character of the work or the lyrics Adding lyrics if none exist

Send Request

Send the request with a selfaddressed stamped envelope to:

the permission department of the publisher if the publisher is the copyright owner

the author c/o publisher's permission department OR the author's address if the author is the copyright owner
