

Adv Tech 2008-09 Initiative: Manufacturing Cluster - Curriculum Development Grant Match

Summary:

Lane is partnering with Lane Workforce Partnership in submitting a Cluster Partnership Grant in Manufacturing. Part of the grant application requires curriculum development matching funds from the College of \$15,000. The grant is in the range of \$300,000 +.

Description:

The plan would be to support 3 prototypes of skills sets that are identified from a needs assessment. Skill sets in modules that would support the "pull system."

A skill set module in CNC could be one. Two others could come these categories: Welding, Engineering Technicians, Machinists, Electrical /Electronic Technicians, Mechanical Drafters.

These funds would not be required if the grant was not awarded.
