Bus/CIT 2008-09 Initiative: Pathways: Create new Database Pathway Certificate

Summary:

Designing and administering large databases is a high demand market need frequently supported by the CIT Advisory Committee - create a marketable Pathways Certificate to meet this need.

Description:

The need for an effective Database Pathways Certificate can be met simply and sustainably by modifying two existing courses (CIS125D and CS275), and creating a third class on Database Administration (CS276).

The alignment and redesign of the CIT curriculum has been the focus of CIT planning all along, starting with the implementation of the CIT Core Curriculum as a separately credentialed certificate aimed at providing an essential foundation to many career choices.

The overarching strategy is to solve the difficult design tension between supporting students and the employment market with needed education either via isolated professional development service classes, or in a credentialed Pathways Certificate "chunk," or in a full two-year AAS degree.

The appropriate target of this initiative is to continue the development of Pathways Certificates as credentialed "chunks" that have use in the marketplace. The CIT Advisory committee has provided clear guidance that this is a needed element.

* creating new College Now articulation possibilities with 125D becoming an initial Pathways class

4. What are up to 3 departmental instructional goals that are met through the development of curriculum in each class?

CIS125D

CIS125D plays a pivotal role in the CIT first year curriculum, providing baseline database knowledge required of all computer science professionals.

CS275 CS276

Both of these courses provide career advancement opportunities for working professionals.

1. A key goal is to provide Pathways Certificates that are valued in the local marketplace. Leveraging the foundational 125D class with an existing professional development service class (CS275) and a new professional development service class (CS276) creates a Pathways credential for which there is significant and increasing demand. It does so economically and sustainably, building on existing and new multi-use courses.

2. This certificate will provide a very valuable "add on" credential for students with many other career and technical degrees and certificates.

3. In a cost-effective way this work will allow the department to reach new segments of the employment community, expanding FTE without increasing cost/FTE

Because this course is foundational for all computer science work, aligning the curriculum into a Pathway will also improve the coherence and value of this course when this material is required by other faculty because both students and faculty will better be able to understand what is covered framed in this larger context.

CS275 CS276

These are taught and developed by faculty who specialize in database topics. As such, many other faculty are professionals who might find these courses of interest in their own professional development.

In addition, every compelling marketing story contributes to the overall strength of the dept. When any of the offerings of the department are marketed well, the overall visibility and viability of the department improves as well.

CIS125D - existing CIT core class

This is a foundational class in technical work, where the use of databases is in increasingly widespread demand.

CS275 - existing professional development class CS276 - professional development class that completes the proposed Pathways Certificate

Together these classes complete a high-demand Pathways Certificate that will be a great competitive advantage for students who complete the credential.

CIS125D CS275 CS276

The general diversity picture in computer technical areas is one of increasing diversity in the computer science student population. Because this initiative targets a standalone Career Pathways certificate in a high-demand, high-wage area of the computer employment market it provides an incremental way for students in areas with dept goals of increasing diversity to relatively quickly gain a market advantage.

CIS125D - existing class CS275 - existing class

CS276 - needed for development

This is a sustainable effort, because the targeted Career Pathway certificate can be created largely on the basis of aligning existing classes. All of the classes have natural course and certificate leads from existing faculty, and don't require additional faculty resources.
