# **Coop Ed 2008-09 Initiative: Increased High School Connections**

## Summary:

Increase number of certified instructors in existing areas. Offer new courses in College Now such as career education, co-op, sustainability, and service learning credit to high school students. Increase and strengthen technical course opportunities for high school students (RTEC).

# **Description:**

The High School Connections office has been key in working with Lane County High Schools and Lane Community College Divisions to increase FTE related to College Now articulations. Over the last 4 years, the FTE from the connections to high schools have increased for 200 to 605. RTEC is a t program which increases career and technical course opportunities for high school students. Over 150 students participated in RTEC last year. In addition, Career Pathways efforts that are closely aligned to K-12 are the focus of the new Perkins grant which is being initiated in 2008-9. Grants to serve this area have been secured for a variety of new activities. Staffing is what is needed to make all of this happen.

1. Funding for staff for High School Connections programs continues and expands the efforts of the past two years. College goals are to continue to concentrate on high school students recruitment and success.

2. This is a continuation of the focus on K-12 enrollment following the LCC Boards of Education's Strategic Conversation with school district partners in 2002. The results have been phenomenal in participating by the high schools in aritulated programs. RTEC (Regional Technical Education Consortium) was established in 2004 as a partnership to expand the career and technical opportunities available for high school students. Career Pathways a state and national effort to provide better coordination and information for students to reach career goals was also coordinated through this office.

#### Describe the resources needed:

As in the last two years, we are requesting funding for the High School Connections office. Combining the high school efforts all in one office has been instrumental in creating better connections with high schools. In addition, it has been a financial strategy for the college going from 200 FTE in 2004 to 605 FTE in 2008. This has largely been due to the increased efforts in creating and expanding College Now connections, both academic and tech prep courses, and establishing a new program called RTEC (Regional

TEchnical Education Consortium) which makes college technical courses available to high school students. The resources needed at \$110,000 for a High School Connections manager position. We are requesting these funds from the Perkins grant.

What specific measurable program outcomes do you expect to achieve with this initiative? The outcomes should be specific enough to be measurable. Also, outline the method that will be used to determine the results.

Outcome: an additional 200 Students @ 4 credits each. Adds 17 FTE or approximately \$34,000.

Unit Resources:

The department has approximatley \$195,000 budgeted. A faculty position is being backfilled by two part-time instructors for the College Now outreach to high schools. One administrative specialist, some part-time staffing for peak activities, and some general expenses are the only current expenses in this department. The benefit of this position over the last two years has brought in over 400 FTE for the college. The High School Connections management staff is the key component.

The focus of the new Perkins grant is to strengthen the connections between secondary and postsecondary programs by instituting more programs of study (career pathways). Staffing for the High School Connections office is the glue that provides for these connections. Students who are aware in high school of the pathways to follow and who can be academically and technically ready to pursue them are the foundation of the outcomes expected in the Carl Perkins grant. Providing placement tests, college credit in high schools and access to college courses, creates a clearer path, less duplication, better preparedness for high school students.

How will funding this initiative increase or sustain the number of CTE students that graduate or receive a one year certificate from Lane and help prepare the students for employment?

By providing better connections to the high schools, students will be better prepared to be successful in college courses and eventually the workforce. Being aware of career pathways opportunities will lead students to high wage employment in a more direct and purposeful way.
