Health Professions 2008-09 Initiative: Continuation of revision of nursing curriculum to meet OCNE requirements.

Summary:

The three second year theory and three second year clinical nursing courses need to be revised to meet the OCNE requirements.

Description:

The revision of the final three theory and three clinical courses in the nursing curriculum will complete the curriculum revision for the nursing program to meet OCNE requirements. This is a mandated activity resulting from Lane's agreement to join with the statewide OCNE nursing curriculum.

The Initiation of the OCNE curriculum began three years ago; the curriculum for the first year of the program was revised last summer and is being implemented in the current academic year. The curriculum for the second year for which this curriculum funding is being requested will be implemented in the 08-09 academic year.

Describe the resources needed:

300 hours of curriculum development funding is needed for the complete revision of Nur 206A and B, Advanced Nursing I, Nur 207A and B, Advanced Nursing II, and 209A and B, Advanced Nursing III. This essentially includes the entire second year of the nursing curriculum.

What specific measurable program outcomes do you expect to achieve with this initiative? The outcomes should be specific enough to be measurable. Also, outline the method that will be used to determine the results.

There are ten competencies which are the outcomes of both of the first two years of the OCNE curriculum. These competencies include:

- 1. personal and professional actions are based on a set of shared core nursing values.
- 2. insights are developed through reflection self-analysis, and self care.
- 3. Ongoing self-directed learning is engaged in.
- 4. Leadership in nursing and health care is demonstrated.
- 5. the nurse collaborates as a part of a health care team.
- 6. the nurse practices within, utilizes and contributes to a broader health care system.
- 7. Relationship-centered care is practiced.
- 8. the nurse communicates effectively.
- 9. the competent nurse makes sound clinical judgments.
- 10. in making practice decisions, the nurse locates, evaluates and uses the best available evidence.
