The program placed this initiative as priority #2 last year. It was linked to maintaining and upgrading existing curricular functions.

This initiative was not funded last year. At that time we had \$40,000. which was ear marked for the booth and was not to be used for anything else. But due to budget cuts the division chair decided to place the funds else where. The goals remain the same. The program continues to need to maintain and upgrade its paint facilities.

The current booth is in need of replacement and has been on the priority list of the advisory committees for the last 30 years a new booth would allow more work to be done by students due to the efficiency of faster dry times as well as a safer environment all new paints contain known carcinogens. The cost of heating the booth would be approx 50% less then our existing booth. Emissions would be cut by 75% helping Lane Community College be a leader in saving the environment.

This would allow students to do better work and would duplicate the equipment that they will use on the job when they leave Lane Community College. The new booths are eco friendly or (green booths) due to the vast savings on energy and the low emissions into the environment.
