Disability Resources is devoted to the intention of these initiatives. The general fund allocation for M&S that provides accommodations totals 8,000. The general fund allocation for timesheet staff who provide services related to accommodating students totals 155,875. Typically, we exceed our general budget due to high demand for legal accommodations.

Additionally, all the staff in the office are working with students with disabilities or preparing accommodations for them. We also have a wide array of equipment and technology that staff utilize on a regular basis for students, and technology available for students to use in order to access the learning environment.
