Initiative Report for Social Science 2009-10

Criminal Justice Program Community Corrections

Summary:

This initiative is for curriculum development funding to be used to re-develop two courses, CJA 130 Introduction to Corrections and CJA 233 Community based Corrections and for the Criminal Justice program to be ready for training students to staff new correctional and mental health facilities soon to be constructed in the region.

Description

This Initiative for the Criminal Justice Program for curriculum development for classes to address the future employment, training, and educational needs for our students in the area of corrections, probation, and parole. While many public safety departments are showing some decreases in funding, the area of corrections is quite the opposite. The City of Springfield, Oregon will open a new jail in August 2009 and the Oregon State Department of Corrections will have a Mental Health Hospital facility near Junction City.

Our program currently offers a single course in Correctional Casework CJA 232. The requested funding would be to re-develop two courses, CJA 130 Introduction to Corrections and CJA 233 Community based Corrections with up-dated information that will serve education and training needs for staff in the facilities. The three corrections classes could then be included in a new certificate with a corrections emphasis.

The initiative is linked in that it is a continuation of curriculum development around public safety issues and needs in Lane County. The Criminal Justice Program is both a transfer and professional technical program.

The creation of core corrections series provides an avenue for students who might make career choices in corrections to meet the expanded career opportunities in corrections with the new Springfield City Jail, Lane County Sheriff's department Adult Corrections, and the building of the new Oregon State Prison to be built in Junction City.

This is simply a re-introduction of two criminal justice classes that had once been taught at Lane Community College. With the increase in focus upon corrections and the employment opportunities in this area, it is consistent with our program to make changes in our curriculum to meet the changing demands of industry. By making the new courses updated ones that address current corrections and detention needs
