Description

Pay for staff time to convene meetings of high school teachers and Lane faculty in career content areas to: Facilitate review of curriculum; assist in mapping course outcomes and student competency attainment; document curriculum changes or adjustments; and determine assessment tools to verify student attainment of competencies.

A 5 year plan to evaluate all career technical programs has been developed collaboratively with Lane ESD. This initiative will implement the assessment plan.
