Distance education/online curriculum development Nursing program Florence cohort

Summary:

Currently we will be starting a new cohort to our Nursing program for Florence. This will be distance education. Looking to develop curriculum in an online format for the future of the Nursing program.

Description

We will be adding a new cohort to our Nursing program for Florence. For the future, we would like to move from a distance education format to a an online/hybrid format. Requesting funds to develop the courses into an online format.

Describe the resources needed:

1st Year - Curriculum development of 7 courses x 70 hrs = 490 x 29.15 = \$14,284 + 4585 (ope)= \$18,869

2nd year Curriculum development of 3 courses x 70 = 210 x 29.15 Year = \$6,122 + 1,965 (ope)= \$8087.00

Training -100 hrs x 29.15= \$2,915.00 + 935=\$3,851.00

Running a side by side comparison of two courses....Pharmacology and Pathophysiology in an on ground and online format and assess for objective outcomes.

0.6 fte for online course and 0.6 for on ground = 1.2 fte $57,600 + 18,490 = \$76,090.00$

total $18,869 + 8087 + 3851 + 76,090 = \$106,896.00$
