Investigate and Purchase Audio-Visual Technology Upgrade

Summary:

According to the ACT, Lane will no longer support audio-taping in technology purchases and upgrades. Since the Speech and Communication Studies Department has relied exclusively on these means to record audio student performance, we need to investigate the facility and affordability, leading to purchase, of a substitute technology for faculty and students.
