Revise and update RD80 curriculum for improved student success and persistence

Summary:

The Academic Learning Skills Department supports curriculum revision for RD 080, an entry level reading class. Students scoring below the minimum reading level on the college placement test are required to take RD 080 and are restricted from most other college-level courses their first term. Thirteen sections are typically offered in the Fall; ten sections in Winter; eight sections in the Spring, and four sections in Summer term. The course is currently taught by eight different instructors.

Description

The RD80 revision process would include analysis of current course objectives, new textbook options (both text and e-text), and online support for students and instructors. The initiative reflects a need to adjust and modify the delivery of Reading 080 to better meet the needs of students, including options for offering the course in hybrid format.

Last year's initiative included a curriculum development project to create hybrid and online versions of Math 10, incorporating Moodle and other new online instructional tools. That project has been completed and ALS currently offers online and hybrid Math 10.

RD 080 serves approximately 700 students per year. This course is required test for students who score below college level on the reading placement test, and for these students RD80 is generally the first class they take in the credit program at the college.

RD 080 serves approximately 700 students per year. This course is a required test for students who score at a certain level on the reading placement test, and it is generally the first class students take in the credit program at the College.

The revised RD 080 curriculum benefits students by expanding learning opportunities for: enhanced ability to read college level material, increased access to technology, and increased skills in using technology.
