Cont Ed 2011-12 Personal Care Aide Enhancement Classes

Summary:

Background:

Ten thousand Baby Boomers now turn 65 daily, in harsh economic times. Families struggle to pay for needed care and states work toward least restrictive and least expensive options for those on Medicaid. Professional in-home care is in great demand and, for those who can't pay for it, there is also a growing demand from family caregivers for professional-quality training.

Local in-home care companies, assisted living facilities, and adult foster homes, through Senior & Disabled Services, approached SAI in 2010 to request development of a 40 hour professional-quality training for personal care aides. Senior & Disabled Services also requested that the training serve the needs of the 260+ family caregivers who receive their support. Lane Workforce Development provided ARRA stimulus grant funding for the first training class, in spring 2010, as a Vocational English and a Second Language (VESL) offering – in recognition of PCA as a high-demand, short-term, "high-enough" wage job. Since then, the class has been offered to the general public in fall 2010 and winter 2011. Both VESL and general public classes will be offered in 2011. In evidence of their appreciation, and need, 10 area employers are offering special hiring considerations to those who pass the final exam and achieve an Award of Completion from the course, including up to \$1.50 more per hour in pay. They also enthusiastically participate in a job fair SAI/CE holds with both PCA and CNA graduates. Senior & Disabled Services and the employers and publicize the training for both potential and current caregivers.

Description

New Initiative: Progression

Local employers have requested additional training for professional caregivers, and some have already offered to cover the tuition for their employees. Senior & Disabled Services and a local group of Parish Nurses, affiliated with PeaceHealth, would like more skill-based training for family caregivers who may not want or need the full 40 hour PCA course. Certified Nursing Assistants and other healthcare professionals may also be interested in some of these courses. For these reasons, SAI would like to develop several "PCA Enhancement" courses. This request for funding would pay for the curriculum development. It would also pay for the training of additional instructors, as all of the PCA classes are now taught by the same instructor.

- Basic Medical Terminology for Professional Caregivers
- Preventing Burnout: Tips for Professional Caregivers

- Alzheimer's/Dementia: What Professional Caregivers Need to Know

- Home Care Medication: Do's and Don'ts for Personal Care Aides

-Enhancing Range of Motion: What Professional Caregivers Need to Know

Describe the resources needed:

Resources Needed: \$4550.

- Initially, 30 hoursof curriculum development was paid for the PCA class by the ARRA grant, at \$23/hour or \$690. For each of five courses, of 6-10 hours duration each, \$23 per teaching hour is requested for curriculum development. For example, for a 10 hour course, \$230 would be requested. (The courses would be 6-10 hours in duration each.) The total would not exceed \$1150.
- 1. In addition, SAI would like to train three (3) additional instructors. Four total instructors would allow the high-demand PCA training to be offered each term, in addition to PCA Enhancement courses. The request would be for 40 hours of training, including onsite assistance of supervised instruction for each of three new instructors, at \$20/hour. Payment to the PCA expert instructor to train the three new instructors would be \$25/hour for 40 hours, or \$1000. The total would not exceed \$3400.

Provide foundational skills classes & support!

-Create of 5 new short-term, low-cost classes for high-demand Personal Care Aides and other professional and family caregivers, provided by four excellent area instructors.

-Cultivate community partnerships through shared publicity of the entire PCA "program" of classes by local employers, (in-home care companies, assisted living facilities, residential care facilities, adult foster homes, etc), Senior & Disabled Services, and other partners.

-Sustain the entire PCA "program" of classes through ongoing support by local employers, Senior & Disabled Services, and other partners who offer scholarships, special hiring considerations, and regular PCA job fair participation.

-Boost FTE & funding for SAI/CE through continuous quality improvement of both the PCA "program" with ongoing input from community partners.
