## Psychological and Social Health

### **Summary:**

To research, develop, and implement a Psychological and Social Health course at Lane Community College in the Health/PE/Athletics Division. This course could be offered using a traditional face-to-face learning format, as well as hybrid and online formats.

## **Description**

This initiative requests curriculum development funding to research and develop a Psychological and Social Health course. Offering a Psychological and Social Health course will expand and broaden upon current health offerings to better meet the needs of students as well as, be pertinent to issues that they face on a day to day basis. The course will specifically address the psychological and social aspects of health, focusing on common mental and emotional health issues, prevention strategies, evidence based treatment modalities, and comprehensive costs to society. A few topics introduced in other health courses (e.g. Personal Health and Global Health) will be comprehensively expanded upon to give the participant an in-depth understanding of the subject matter and to develop comprehensive and activity based skills to help prevent emotional and social distress and other health issues that stem from this. Several community colleges and Universities across the country offer similar courses, and considering the increase prevalence of psychological issues like, depression, anger, anxiety and suicide are in our society, this course would serve a vital role in providing knowledge and practical skills that are often unavailable.

This course offering furthers the achievement of all three top goals of the Health/PE/Athletic Division.

Goal 1: Increase the diversity of our curriculum offerings.

The Psychological and Social Health course increases the diversity of our curriculum offerings. The division currently offers 10 different health courses that are consistently over-enrolled. The development of this course would complement the existing health offerings while at the same time provide a subject area in health that often goes unaddressed and yet is critical for the well being of our society.

Goal 2: Expand the learning environment by offering more distance learning options.

The developer of this course currently uses the Moodle learning management system to augment and complement the traditional classroom-learning environment. The course developer plans to offer the Psychological and Social Health course as on online and/or hybrid course in addition to the traditional lecture format.

Goal 3: Offer sections at various times to meet student needs.

The development of an additional health course will enable the department to increase the diversity in the times and learning modalities for the health courses offered to better meet student needs.

- Videos and other technological resources will be researched and reviewed to offer additional and complementary perspectives related to Psychosocial Health
- Online Quizzes and exams and assessment tools will be created to evaluate student understanding of the course material.

## 4. What are up to 3 departmental instructional goals that are met through the development of curriculum in each class?

Developing and offering a Psychological and Social Health course will meet the following departmental instructional goals:

- Increase the diversity of our curriculum offerings
- Expand the learning environment by offering more distance learning options.
- Offer sections at various times to meet student needs.

# 5. List each course number (or title) and give the value of the development of curriculum in each course to other faculty members.

The Psychological and Social Health course will be valuable to other health faculty members because some of the course curriculum developed could be used in other health/wellness courses currently offered in the department and on campus for staff/faculty. The instructor of the course could work collaboratively with other health instructors to discuss the integration of this curriculum into existing health education courses.

Depending on the number of sections offered each term, the number of students served by the development of curriculum will vary. For each section of the course offered, approximately 33 students will be served each term. The course would be offered each term.

# 7. List each course number (or title) and give the specific benefits to students that you expect from the development of curriculum in each class.

The specific benefits we would expect students to receive from the development of a Psychological and Social Health course would be the following:

- Thorough understanding of the relationship between psychosocial health and all other dimensions of one's health wellness
- Increase knowledge and awareness of the community health issues that are related to psychological (mental and emotional) and social (individual and community) health.
- Increased understanding and sensitivity about the social issues that stigmatize individuals and groups related to mental health conditions and treatment
- Enhancement of personal communication skills and the development of new tools to increase social and cultural competency
- Increased self awareness of the underlying social and physiological processes of one's emotional
  experience and potential negative outcomes such as; stress, anxiety, conflict, and physical health issues
- Increased knowledge, understanding and skills related to the improvement of one's emotional and social intelligence
- Students will improve their ability to assess personal feelings, behaviors, social pressures and act in a
  way that enhances one's health and happiness

- Increased knowledge and skills related to the use of humor, compassion and altruism to improve individual and community health/wellness
- Students will explore the connections between psychosocial health and community sustainability
- Student's will re-learn how to play with others and be involved in activities that they enjoy and feel
  passionate about, which can lead to increased health and wellness
- Increased knowledge of and ability to research common mental health conditions, treatment options and outcomes for improved health
- Improved use of critical thinking skills

# 8. List each course number (or title) and give the specific benefits for diversity that you expect from the development of curriculum in each class.

The Psychological and Social Health course curriculum would include various aspects of diversity, including, but not limited to, gender, age, socioeconomic background, sexual orientation, and ethnic. This course would improve students understanding of cultural competency as well as the cultural and social intolerance related to different aspects of psychosocial health.

# 9. List each course number (or title) and give the specific benefits to sustainability that you expect from the development of curriculum in each class.

The Psychosocial course would positively reinforce the benefits of all aspects of sustainability.

Social sustainability benefits can be achieved as a result of the course in many ways; ending the social stigma related to mental health issues and conditions, addressing the biases inherent in both talking about and experiencing our emotions. This course will also address the socially constructed hierarchies and how they impact both the psychological and social health of individuals and the community.

Student's will also explore how social stigma's related to mental, emotional and social health can negatively impact employment, health, personal identity, relationships, healthcare, and acceptance into college. This course will encourage practicing respectful behavior toward all people, regardless of gender, gender identity, ethnicity or ethnic origin, age, sexual orientation or social status.

The economic aspects of sustainability will be addressed in this course by exploring the social hierarchies and how they impact one's ability to meet their basic needs. We will explore Abraham Maslow's hierarchy of needs theory and examines aspects of our own economy that may enhance or detract from one's ability to meet or exceed basic needs.

The exploration of both social and economic aspects of sustainability will be looked at with ecological sustainability as a potential outcome of a healthy social system. Student's will explore the connections to these 3 aspects of sustainability both from a theoretical standpoint and by doing activities outdoors that will be a hands on look at the outcomes of economic and social actions on the environment. Students will also explore new ways to enhance their own psychosocial health through enhancing their own economic, social and ecological sustainability behaviors.

Developing and offering a Psychosocial health course would increase distributed learning within the Health/PE/Athletics Division as well as campus wide. Within our division we have seen an amazing need for distributive learning, especially in times when people need to both work and further their education simultaneously. This course will be offered online or as a hybrid course which would increase the availability of distributed learning at Lane Community College and throughout our community.
