



Tuition Rates

Tuition per Credit -- Oregon Resident


The resident tuition rate per credit increased 75 percent during the six-year period from 1998-99 to 2003-04. During the same period, the Portland area Consumer Price Index (CPI) increased 13.6 percent. Tuition for non-resident and international students increased 75.6 percent between 1998-99 and 2003-04.

The Portland Consumer Price Index (CPI) represents the average price level for the 36-month period from 1982-84, and is set equal to 100. This index represents the average change over time in the prices paid by urban consumers for a market basket of consumer goods and services. The Consumer Price Index that covers All Urban Consumers (about 87% of the population) is used below.



include Board of Education, Purchasing Svcs., Ofc. of the President, LCC Foundation, Downtown Ctr., College Finance, Computer Svcs.



Cost per FTE




Total General Fund Expenditures per FTE

The Cost per FTE shown is calculated by dividing the total General Fund expenditures by the total student FTE.

Total General Fund expenditures increased 10.7% from 1998-99 to 2002-03 while total student FTE increased 3.3%, resulting in a cost per FTE ratio that increased 7.2%.

An adjustment was made to the method used to calculate FTE for credit classes for winter and spring terms 1999 which led to a slight decline in FTE for those terms.




Student Financial Aid
